Marijuana Land Use Application Types & Fees TYPE I APPLICATIONS (Review Time Approx. 2-3 Weeks):

Outdoor and/or Indoor Grow Using "Existing" Buildings

i. Forms required:

- Land Use Compatibility Statement (LUCS) from the OLCC for a Producer
- County <u>OLCC LUCS Supplemental Form</u> (includes owners signatures)

ii. Fees: LUCS application \$550

Outdoor or Indoor Grow Using "New" Building(s) or Hoop House(s)

i. Forms required:

- <u>Land Use Compatibility Statement</u> (LUCS) from the OLCC for a *Producer*
- Agricultural Building Application for an agricultural building permit
 OR
- Land Use (Building) Permit Application for an accessory building permit

ii. Fees:

- \$550 for the LUCS
- \$100 (if submitted at the same time as the LUCS) for either the Agricultural or Land Use (Building) Permit Application.; \$200 if submitted separate from the LUCS
- Applicable Building Department fees

TYPE II APPLICATIONS (Review Time Approx. 3-6 Months):

Marijuana Processing Facility (EFU Zoned Property)

i. Forms required:

- Administrative Land Use Application if *approved then*:
- Land Use Compatibility Statement (LUCS) from the OLCC for a *Processor*
- If a new building is needed:
 - Agricultural Building Application for an agricultural building permit
 OR
 - Land Use (Building) Permit Application for an accessory building permit

ii. Fees:

- \$1,800 for Administrative Land Use Application
- \$550 for LUCS (must be submitted after approval as a separate application)
- If a new building is needed:
 - -\$100 for a Land Use (Building) Permit application for an accessory or agricultural building permit.
- Applicable Building Department fees

TYPE II APPLICATIONS Continued (Review Time Approx. 3-6 Months)...

Industrial Land Use Permit (ILUP) for an "Indoor" Grow, Processing, or Wholesaling

i. Forms required:

Administrative Land Use Application for an Industrial Land Use Permit (ILUP)

If approved then:

- Land Use Compatibility Statement (LUCS) from the OLCC for a Producer, Processor, or Wholesaler
- If a new building is needed:
 - Land Use (Building) Permit Application for an industrial building permit

ii. Fees:

- \$1,800 for the Administrative Land Use Application
- \$550 for the LUCS (must be submitted after approval as a separate application)
- If a new building is needed:
 - \$100 for a Land Use (Building) Permit application for an industrial, building depending on when it is sub mitted.
- Applicable Building Department fees

Commercial Land Use Permit (CLUP) for "Retail" Sales

i. Forms required:

Administrative Land Use Application for a Commercial Land Use Permit (CLUP)

If approved then:

- Land Use Compatibility Statement (LUCS) from the OLCC for a Retailer
- If a new building is needed:
 - Land Use (Building) Permit Application for a commercial building permit

ii. Fees:

- \$1,800 for the Administrative Land Use Application
- \$550 for the LUCS (must be submitted after approval as a separate application)
- If a new building is needed:
 - \$100 for a Land Use (Building) Permit application for a commercial building, depending on when it is submitted.
- Applicable Building Department fees
